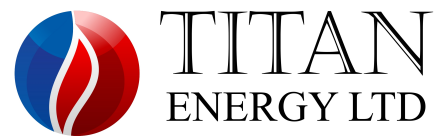


TITAN & ENCORE IN STRATEGIC PARTNERSHIP

ASX Announcement | 4 May 2015



Australian oil and gas company Titan Energy Ltd (ASX: TTE, OTC: TTENY) (Titan or the Company) is pleased to announce it has successfully negotiated a discounted, long-term daily drilling rate with Encore Drilling LLC (Encore) as part of the Company's aggressive ongoing drilling program.

Managing Director Paul Garner said, "The Company was delighted to have Encore as a long term committed drilling partner."

"One of the keys to success in the Texas Gulf Coast is having the right equipment, skills and experience on your drilling team. We couldn't be any more delighted to have Don Henrich and his highly talented team on board."

Titan has placed 45 million, fully paid shares valued at US\$900,000 (AU\$1.14 million) to the principals of Encore. The shares will be held in voluntary escrow. The escrow period will end on 30 October 2015.

"Whilst we are mindful of dilution, we see that this agreement will forge a strategic partnership with Encore and provide a long-term value for Titan Energy and its shareholders," Mr. Garner went on to say. "Don is as excited as we are about the future of Titan and recognises the upside potential of our fields."

USE OF FUNDS

The funds raised will be used to drill the first of the 100%, Titan owned exploration wells on the eastern and southern flanks of Allen Dome and on the recently acquired Boling Dome. This, and potentially several other exploration wells, are considered to be a critical components in proving up further drilling locations for the US\$75 million development project which is being funded by Gulf South (see ASX announcement 28/04/2015).

"This is a very exciting time for Titan Energy and its shareholders as we continue to work hard to unlock the highly prospective and largely under-developed Gulf Coast projects." Mr. Garner said.

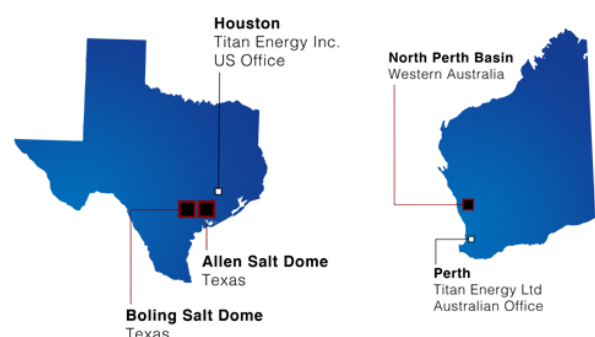
